Board suggested it might be a good idea to obtain a second structural report.

Mrs. Perryman went over the Locker Policy. The Board recommended that the fee is an annual fee.

Rising Leaders Academy Locker Agreement and Expectations

Thanks to the generosity of Rising Leaders' families, our school has obtained new lockers that are available for middle/high school students' use. Lockers are the property of Rising Leaders Academy, Inc., and students should remember that using the school lockers is a privilege and not a right. Only school-issued combination locks will be permitted on the lockers. Students may rent a lock for \$5.00 annually, and locks are to remain at the school at the end of the year. Lockers will only be assigned if the student and parent/guardian agree to the following locker rules and expectations.

Carefully read the following guidelines as you accept a locker from Rising Leaders Academy.

Violation of these rules will result in the loss of the privilege of having a locker.

- 1. The school assumes NO responsibility for loss or damage to personal or school items in
- an unlocked or locked locker.
- 2. Rising Leaders Academy reserves the right to search lockers at any time.
- 3. Valuables must NOT be kept in the lockers.
- 4. Students should keep only items necessary for school in the lockers (i.e. textbooks,

school supplies).

- 5. The storage of food and drink in the locker is not allowed; however, students may store
- contained lunches. Food items are to be removed by the end of each school day.
- 6. Students are solely responsible for the contents of their lockers and should not share
- their lockers with other students; nor divulge locker combinations to other students.
- 7. Lockers must be in the same condition at the end of the school year as they were in the

beginning of the school year. Students are not to write, place stickers, or vandalize lockers in any manner. Students guilty of such infractions will be charged to the fullest

extent allowed by the *Rising Leaders Academy/Bay District Schools* Student Conduct and Discipline.

- 8. Students may not use lockers, without permission, during class time.
- 9. Students will not have access to lockers until 7:40 a.m., and will only access lockers at their approved times.
- 10. Being tardy to class, due to going to a locker, is not acceptable and will result in an unexcused tardy.
- 11. If students are having problems with lockers, they are to report this to their homeroom teachers.
